## PURPOSE

The WiN Global Nuclear Future Award provides sponsorship for an individual who has demonstrated outstanding commitment to WiN Global and its Chapters. WiN Global would like to recognise and enable young nuclear professionals of high potential to participate in the WiN Global Annual Conference who would otherwise not be able to take part.

## CRITERIA TO APPLY

1. Any individual below 40 years of age, with at least 3 years professional experience in the nuclear field.
2. Current members of WiN Global and one of its Chapters.
3. Have contributed by successfully implementing a special initiative or project related to the WiN Global mission, vision and objectives, either in WiN Global or in one of its Chapters, during the past 1-2 calendar years.

## PRIZE

The successful candidate will be offered free registration to the WiN Global Annual Conference in addition to funding for attendance up to a maximum of EUR 2000 (subject to terms and conditions).

The successful recipient will also be offered the opportunity to speak at the Annual Conference.

The WiN Global Excellence Award honours an individual working in nuclear communications, education, mentoring and leadership programmes in local, national and international forums with audiences ranging from teachers and students to local government officials to national news media.

## CRITERIA TO APPLY

A nominee must have demonstrated excellence in one or more of the following areas:

**Communications** (communicating the applications of nuclear and radiation related technologies), **Education** (working with students, teachers and school programmes), **Mentoring** (supporting students, new employees and others seeking professional growth in nuclear and radiation related technologies) and **Leadership** (upholding the WiN Global vision, mission and objectives and growing the WiN Global organisation).

## PRIZE

The successful candidate will be offered free registration to the WiN Global Annual Conference and receive a framed certificate.

This will be presented at the Annual Conference (where possible).

The winner of the Award will also be recognised in all WIN Global publications and communications.

The successful candidate or organisation will be offered ONE free registration place at the WiN Global Conference and receive a framed certificate.


This will be presented at the WiN Global Annual Conference (where possible).
